Rowing Association of Haryana

The Rowing Association of Haryana has sent a list of three councilors. The entire list of the Rowing Association of Haryana is hereby rejected as the said association had been downgraded as an associate member by RFI in its EC Meeting dated 09.06.2017 by the executive committee of RFI. From the said date the Rowing Association of Haryana has been participating only as Associate member and hence as per the Rules of RFI, the Rowing association of Haryana is not entitled to participate and Vote in the Election process.

ROWING AND SWEEP ASSOCIATION, CHANDIGARH (RSAC)

The list of nominated councilors sent by Rowing and Sweep Association, Chandigarh is hereby rejected for the reason that the said association is not an affiliate of Rowing Federation of India. There is already a full fledged affiliated association viz., Chandigarh Rowing Association, thus the said Chandigarh Rowing Association alone is entitled to send its nominated councilors for the election 2020-2024. RSAC is an association formed recently and is not a recognised Association by RFI, and is not affiliated to RFI

In this regard I have perused the RSAC letter dated 07.11.2019 and also the letter sent by Chandigarh Rowing Association (CRA) sent by Email along with copies of judgment of Hon'ble Civil Judge 'Junior Division', Chandigarh passed in 26.09.2019. The Case for grant of Interim Injunction against CRA which is the official recognized affiliated association of RFI, sought for by RSAC has been dismissed. In view of the aforesaid reasons the nomination sent by RSAC is not valid and the same is rejected.

PUNJAB AMATEUR ROWING ASSOCIATION (PARA)

It is found that there exist two groups within PARA. In this regard the Executive Committee Meeting dated 13.10.2019 held at Bhopal had unanimously resolved and directed both the warring groups to mutually agree and nominate councilors for the ensuing RFI elections, to be signed both by the President/Secretary, and to submit the same by 30.10.2019 to RFI with a specific condition that failing compliance with the decision, PARA would not be able to participate in the elections. But till date, even after arrangement of election schedule no agreed list signed by both groups have been received.)

RFI EC dated 13.10.2019, I am unable to accept any of the nominated councilors of both the groups and thus the nominated list of both the rival claimants from PARA as referred above are rejected.

UTTARAKHAND ROWING ASSOCIATION (UKD)

In respect of the list of Nominated councilors sent by UKD, I have received a set of three nominated councilors duly signed by acting president/ vice -president and treasurer of UKD and another set of three councilors duly signed by the president and secretary UKD.

By a circular issued with regard to nomination of three councilors by respective affiliated associations, it has been notified that the names of three nominated councilors shall be sent duly signed by president/secretary. It has also been clearly stated that nomination otherwise received shall be rejected.
