The Anti-Doping Disciplinary Panel (ADDP)

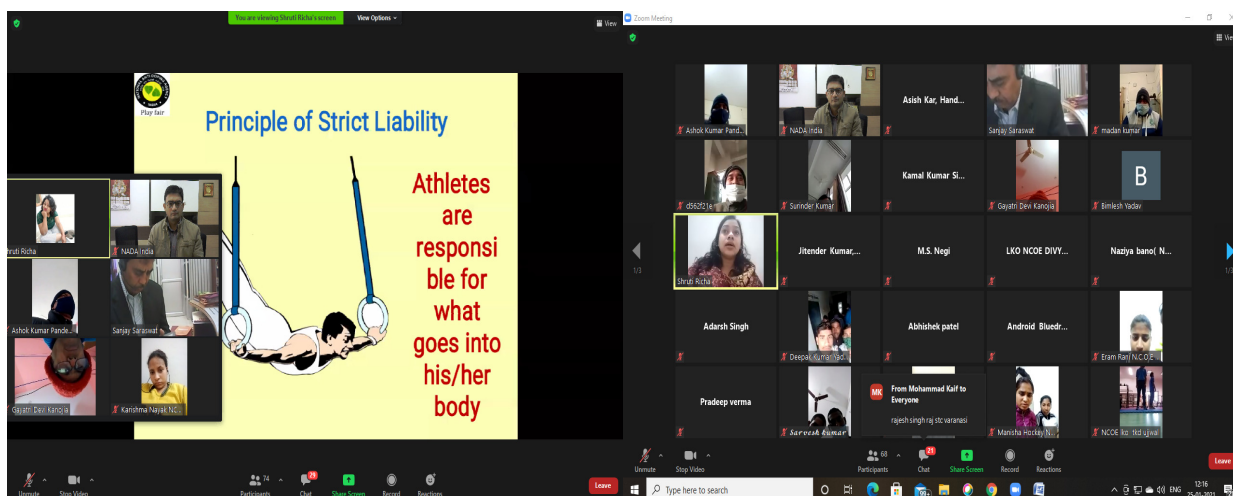

and time fixed by the Panel for hearing. The Panel during the month of January, 2021 issued one (1) order as per the following details:

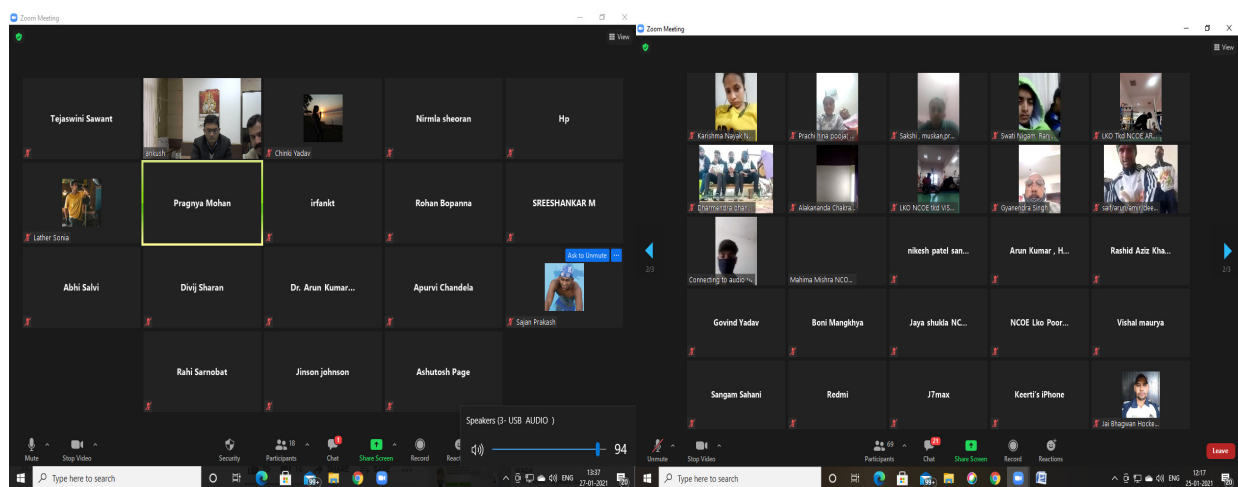

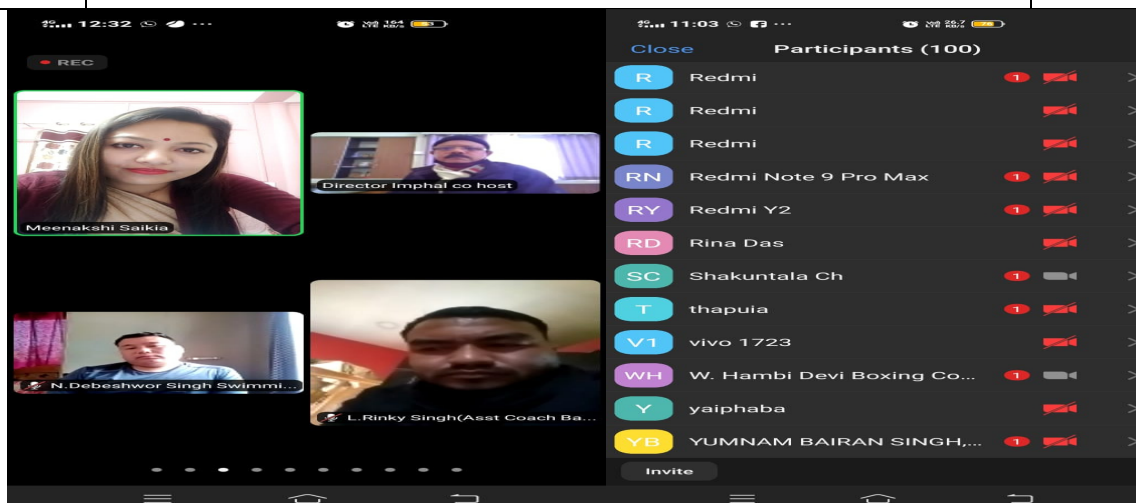


Webinar on Substances of Abuse/ Drugs and WADA 2021 Prohibited substances held on 27 January 2021 for RTP players identified by NADA

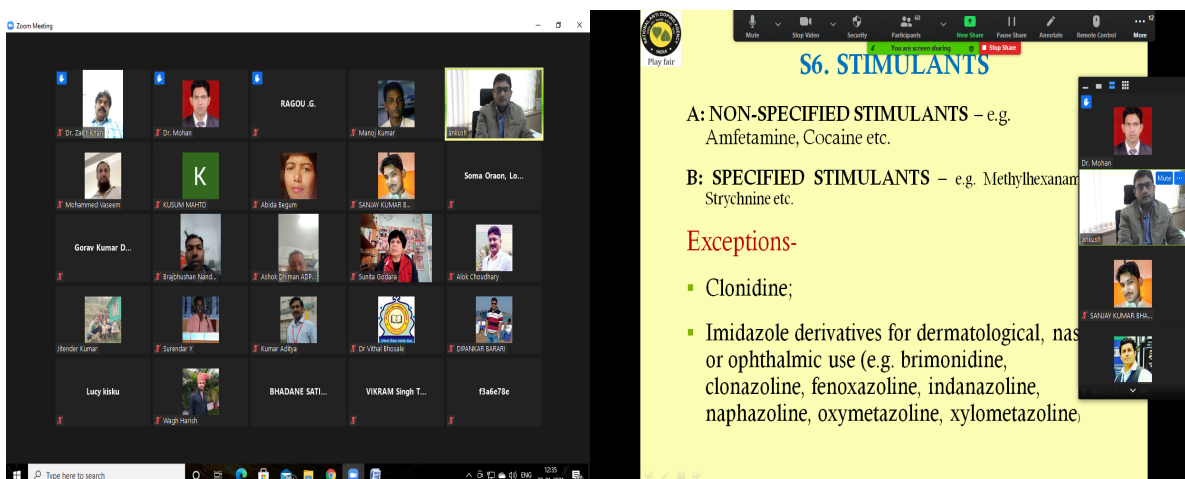
